Acupuncture physical exam and differential diagnosis; 3. Acupuncture point location, including underlying anatomy; 4. Acupuncture needling technique; 5. General injection safety; 3. Acupuncture point injection therapy; 7. Pharmacology; and 8. Clean Needle Technique. 9. For the use of injectable substances prepared from oriental herbs, completion of training in Chinese herbology and injection of Chinese herbal injectables is required. To demonstrate satisfying the training requirements in Chinese herbology and injection of Chinese herbal injectables the Director will accept NCCAOM, or a successor organization's, certification in Chinese herbology and/or certification in Oriental Medicine. 10. For the use of substances listed in (E)(3)(a)(12-17), instruction on the use of inhaled O2 and IM epinephrine for emergency use is required.
